4. Rain Policy

In the event of rain, and the function is not able to be held, rain checks will be issued to the organizer. If any groups are unable to complete the function due to rain, rain checks will be issued for remaining holes, for each group.

5. Head Golf Professional Assistance

Golf Professional and staff will assist when requested with event tally sheets, coordinate with event chairperson and assist with purchases of prizes and gift certificates from WGC.

6. Payment

Balance due shall be made on the day of the function, before event begins golfing. Payment methods accepted are cash, check, credit card.

7. Requirements

Each player must have his own set of clubs. Shirts must be worn. Non-metal spikes allowed only.

8. Liability

Westhaven Golf Club (WGC) is not responsible for supervising Customer's guests or the Customer's guests' behavior. Customer shall be liable to WGC for Customer's or Customer's guests' negligent acts or willful misconduct, and Customer agrees to pay for any property damage created thereby.

Customer agrees WGC shall not be responsible for damages to or loss of Customer's or Customer's guests property. Customer agrees to indemnify WGC and hold WGC harmless from any and all liability, loss of damage, including reasonable attorney fees and court costs which it may occur as a result of Customer's or Customer's guests negligent acts or willful misconduct or as a result of any damages to or loss of Customer's or Customer's guests property.

WGC shall not be liable to Customer for loss of profit or actual or consequential damages occasioned by its inability to perform any of its obligations under this Agreement by reason of fire, strikes, war, civil disturbances, acts of God, unavoidable casualties, public carrier delays, inability to obtain necessary supplies or acts of public authorities.

9. Breach of Agreement

In the event of a breach of Customer of the Agreement, Customer shall pay all cost and expenses including actual attorney's fees incurred by WGC to enforce this Agreement against Customers.

10. No Carry On

11. Laws of the State of Wisconsin

This Agreement shall be governed by and construed in accordance with the laws of the State of Wisconsin. This Agreement contains the entire understanding and agreement of the parties with respect to the subject matter hereof and supercedes all prior oral and written agreements.
